**Declaration of Election Results:** in upcoming Annual State General Body Meeting MAHARAD 2025

A member cannot PROPOSE more than 1 Candidate and cannot SECOND the proposal of more than 1 candidate. The member cannot propose &/or second more than 1 candidate filing nominations for the same post. A candidate should not propose or second any other candidate for any post.

Criteria for various posts will be the same as mentioned in constitution of MSBIRIA and reproduced below.

No correspondence shall be entertained by the MSBIRIA Office in the matter of nominations.

Proforma for filing nominations is given below.

#### **Elections will be Held for the Following Posts:**

<b>President Elect – (One post)</b>	Should be a Continuous Uninterrupted Member of MSBIRIA for atleast <b>10 Years</b> and Should have an experience of <b>2 Years</b> as member of MSBIRIA Executive Council
<b>Vice President – (Two posts)</b>	Should be a Continuous Uninterrupted Member of MSBIRIA for atleast <b>7 Years</b> and Should have an experience of <b>2 Years</b> as member of MSBIRIA Executive Council
<b>Vice President – Female (One)</b>	Should be a Continuous Uninterrupted Member of MSBIRIA for atleast <b>5 Years</b> and Should have an experience of <b>2 Years</b> as member of MSBIRIA Executive Council
<b>Treasurer – (One post):</b>	Should be a Continuous Uninterrupted Member of MSBIRIA for atleast <b>5 Years</b> and should have an experience of <b>2 Years</b> as member of MSBIRIA Executive Council
<b>Central Council Member – (Four posts)</b>	Should be a Continuous Uninterrupted Member of MSBIRIA for atleast <b>3 Years</b> .
<b>Executive Committee Member – (Five posts)</b>	Should be a Continuous Uninterrupted Member of MSBIRIA for atleast <b>3 Years</b>
<b>Executive Committee Member – Female (One post)</b>	Should be a Continuous Uninterrupted Member of MSBIRIA for atleast <b>3 Years</b>

- **Tenure of the Treasurer is for Two Years.**
- **For rest of the above-mentioned posts, the tenure is of 1 year.**
- A person cannot be President, Vice President or Secretary for more than 2 terms of each post.
- A person cannot be Executive Committee Member or Central Council Member for more than 4 consecutive years each.
