

Annual General Body Meeting of MSBIRIA was to be held on 10th December 2022 at 05.30 pm at Hall B CIDCO Convention Centre, Navi Mumbai, Vashi during 45th Annual State Conference of MSBIRIA. However due to delayed lecture schedules continuing in Hall B & on insistence of senior MSBIRIA and IRIA members, it was held in Conference Hall no 4 besides Hall B from 6 pm onwards.

1. Dr Shailesh Sangani, President of MSBIRIA chaired the meeting & welcomed all
2. Obituaries-Condolences One minute Silence was observed as a mark of condolences for recent obituary of Dr. N. G. Deshmukh, Senior Radiologist from Solapur.
 - i. Proposal for starting an Oration in the name of Dr. N. G. Deshmukh was proposed by Dr Pradeep Gandhi (PCMC) as per the wish of his son Dr Pradeep Deshmukh.
 - ii. Dr Jignesh Thakkar, Past President IRIA proposed to form an Oration Committee to decide – Guidelines for starting the oration like
 - a. Money required for MSBIRIA
 - b. Duration like 3 to 5 Yrs
 - c. Look if any criteria of IRIA for thisDr Harish Chandak seconded it.
3. President Dr ShaileshSangani at the outset apologised for the mistake by the anchoring team in not calling up the president elect on stage earlier as per protocol due to human error. He also apologised for any other faults in maintaining protocols and suggested to form a Protocol committee as there was no written protocol in MSBIRIA constitution. It was welcomed by all.
4. **New Team of MSBIRIA 2023-2024** Dr Omprakash Bhangadiya, the election Officer along with President Dr Balasaheb Kitture and Secretary Dr Sandeep Pansare had declared the results of recent MSBIRIA elections held in Nov 2022.

Dr Shailesh Sangani, President MSBIRIA 2023 announced name of Dr Chetan Singhal (Navi Mumbai) for the post of Joint Secretary and Secretary Dr Pravin Sagole announced name of Dr Sandeep Mahajan (Nagpur) for the other post of Joint Secretary, which was passed unanimously.

The office thanked Election committee for carrying out fair and peaceful elections.

5. Dr Pradeep Gandhi President Elect MSBIRIA 2023 delivered his Welcome Speech and promise to be loyal and fair to the office of MSBIRIA during his tenure.
6. The minutes of GBM held at Kolhapur during Maharad 2021 were passed by the forum.
7. Dr Sandeep Pansare Secretary General of MSBIRIA 2022 published 34 pages Annual Report of MSBIRIA for the Year 2022 along with separate Annexure Report of VIDRAD as it was very much exhaustive (53 pages) and not possible to merge with rest of Maharashtra report.
8. Dr Kishor Bhandari Treasurer MSBIRIA 2022 read the audited report of MSBIRIA for the financial year 2021-22 and mentioned the total collection was Rs. 25, 0400=00 up to march 2022 and Fixed Deposit of Rs. 25 Lacs was made. He also summarised unaudited concise financial report till Nov 22. MSBIRIA now had (145L old +35L New) 180 Lakh Rs Fixed Deposits in Bank till date.
9. MCR Report was read by Dr Sanjay Desale Chairman of MCR and Immediate Past President of MSBIRIA.
10. The criteria for bid by the State Chapter for IRIA Annual Conference was discussed, according to which only those state chapters having 80 G & 12A can bid for the event. So it was decided to complete paper work for the getting 80G and 12A for MSBIRIA under the name of Radiology & Imaging Association, Chapter Jalna this year and then bid for the event later.
11. Place for MSBIRIA 46th Annual Conference (Maharad 2023) was finalized at PCMC. The exact venue and further details to be submitted by Dr Pradeep Gandhi.
12. Dr Sandeep Kavthale, Secretary General IRIA suggested that IMAGICON Annual Conference conducted by Nashik Chapter can be held under MSBIRIA on 'Profit Sharing Module'. Details of module to be discussed and refined later in Executive members meeting.
13. It was discussed to find suitable C.A. as per the convenience of new President, Secretary and Treasurer and appoint him for next year financial term as all were not satisfied with our current C.A. Firm.
14. It was also discussed to appoint a Legal Advisor for MSBIRIA.
15. Dr Ulhas Mahajan proposal for Amendment in constitution which stated that any office bearer of MSBIRIA and IRIA should not be the member of any other forum where there could be conflict of interest. Dr Harish Chandak raised the issue that there was no definite definition of term either Office Bearer or the term Conflict of Interest. So it was decided to form the Constitutional Committee to discuss this issue and specifically define the terms as per above.
16. It was decided that from here onwards all such proposals of amendments to be first listed properly and circulated to all members of MSBIRIA for their knowledge and then only discussed in next GBM.

17. Any Other Matter with permission of Chair

Dr Snehal Vaidya Jibhkate, Secretary of VIDRAD asked the question regarding the 'Criteria for selecting the Best City Chapter award' which created lot of controversies and chaos in GBM. It was finally decided that the committee should be formed to decide the criteria for best city chapter award to be given in Maharad annually.

18. Dr Sushant Badane and Dr Rajendra Mehta raised the issue of contribution of MSBIRIA for funds of Maharashtra State Olympic Players for Amritsar Feb 2023. It was decided by all that MSBIRIA will contribute 50% registration fees of IRIA (Approx. Rs. 6000 per head) to such players. Dr Sushant & Dr Rajendra were given the responsibility to make list of such players. It was also decided that this contribution is one time and limited for this time only. If any such event continues to happen in future the MSBIRIA will form the separate committee to decide on the financial contribution by MSBIRIA for such players in future.

19. Secretary MMSBIRIA gave the vote of thanks to each and every members present for the GBM and the meeting was concluded.
